**House Bill 243 (Glanton, Mike of the 75<sup>th</sup>) Georgia Judicial Retirement System; members shall be eligible to transfer funds; provide**

**House Bill 292 (Battles, Paul of the 15<sup>th</sup>) Magistrates Retirement Fund of Georgia; maximum average final monthly compensation calculated in determining benefits; establish**

**House Bill 385 (Battles, Paul of the 15<sup>th</sup>) Employee’s Retirement System of Georgia; term credit means creditable service; define**

**House Bill 386 (Battles, Paul of the 15<sup>th</sup>) Teacher’s Retirement System of Georgia; annuity savings fund; define**

**House Bill 460 (Weldon, Tom of the 3<sup>rd</sup>) Georgia Firefighters’ Pension Fund; no person under a sentence of confinement shall be eligible for membership; provide**

**House Bill 477 (Powell, Jay of the 171<sup>st</sup>) Employees’ Retirement System of Georgia; Georgia Judicial Retirement System; transfer service credit**

**House Bill 516 (Coomer, Christian of the 14<sup>th</sup>) Retirement and pensions; election to participate in Regents Retirement Plan in lieu of Teachers Retirement System of Georgia shall be revocable at will; provide**

**House Bill 579 (Weldon, Tom of the 3<sup>rd</sup>) Georgia Judicial Retirement System; member who was serving in full-time position on retirement may use prior part-time service for vesting; provide**

**House Bill 580 (Weldon, Tom of the 3<sup>rd</sup>) Superior Court Clerk’s Retirement Fund; provide spousal survivor’s benefit**

**House Bill 601 (Maxwell, Howard of the 17<sup>th</sup>) Judges of the Probate Courts Retirement Fund of Georgia; define certain terms; provision**

**House Bill 646 (Fleming, Barry of the 121<sup>st</sup>) Magistrates Retirement Fund of Georgia; part-time chief magistrates may become members of such fund; provide**
