

## Summary of Responsibilities

After arriving one hour prior to the start of session, each Page is *expected* to serve from the convening of daily session until its adjournment.

All Pages are *required* to attend a Page Orientation that will take place 30 minutes before session begins. Attendance to this orientation is crucial; it is here Pages will watch the House Page Instructional Video and will be assigned specific responsibilities.

Throughout the session day, Pages will be seated outside the House Chamber and will be sent individually to deliver messages to representatives using a rotation system. Pages will deliver documents, bills, messages, and letters between various legislators and the public.

When a student is not paging it is important that he or she remain seated so that traffic can move freely outside the chamber doors.

Pages serve continuously throughout the day and will break when the House of Representatives enters a recess.

If, for any reason, a Page must leave before the end of the legislative day please notify the Page Staff at the time of registration.

## Arrival Times

Pages are expected to arrive one hour before the legislative session day begins.

On the evening before your date of service, please visit the House website at [www.house.ga.gov](http://www.house.ga.gov). The start time for the following session day will be in red at the bottom of the page. You may also call (404) 463-5414 for the most up-to-date session start times.

### Example:

**Session start time is 10:00am,  
Pages must arrive at 9:00am.**

## Registration

All Pages must be signed in by a parent or guardian to be completely registered. Page Program registration is located in front of the House Chamber, Room 326, on the third floor of the State Capitol. Each Page must check-in and checkout with a member of the Page Staff.

The ONLY exception to this rule is if the Page drives himself or

herself to the State Capitol. However, in this case, Pages who are 16 years of age must still completely register by signing in.

All students under the age of 16 must have the signature of a parent or guardian in order to Page.

## Dress Code & Rules

Paging requires a full day of walking throughout the Capitol building, as such dress code is strictly enforced and should be respectable, modest, and appropriate, yet comfortable; resembling business casual attire.

Attire for boys typically includes: comfortable shoes, dress pants, and a dress shirt. Sport coats and ties are optional.

## Lunch & Dinner

It is important to note that every legislative day does not have a lunch break. Only on legislative days that House members recess for a lunch break will the Pages be provided lunch (this lunch will be provided by the Page Program). This lunch will include pizza or a fried Chick-fil-A sandwich, chips, a chocolate chip cookie, and a soft drink or water.

Vegetarian or alternative lunches are not provided by the Page Pro-

gram, so if you have any dietary needs that restrict you from eating the provided lunch, please bring your own lunch or make arrangements with your sponsoring representative's office.

Attire for girls consists of a sensible shirt, dress pants, a knee length skirt, or dress.

Shoes must be worn at all times, therefore we recommend comfortable, low-heeled shoes.

**Prohibited clothing:** Any student wearing a sweatshirt, t-shirt, skirt above the knee, strapless or spaghetti strap top or dress, low cut blouse, jeans, or shorts will not be allowed to page.

Since the time for the lunch recess is determined by each legislative day's calendar, Pages are usually served lunch between 12:00–1:00 p.m.

Dinner is not provided to any Page on long legislative days. Pages

staying on long legislative days with a dinner break need to communicate with the sponsoring representative's office for dinner arrangements.

On longer legislative days photos may be taken periodically at the discretion of the Speaker; not the sponsoring representative. On these days, the Page staff or a staff member of the House will notify the Page and the sponsoring representative for his or her photo.

Pages are not allowed to use electronic devices and have the option to secure these items with the Page staff at the time of registration, before session begins.

Page photos are automatically ordered, printed and delivered to each representative's office. It is the responsibility of each representative to mail the photograph.

On longer legislative days photos may be taken periodically at the discretion of the Speaker; not the sponsoring representative. On





## Pay & Certificate

Each Page is paid \$10.00 for their service to the Georgia House of Representatives.

Each Page will receive a certificate of service at the end of the day. This certificate will serve as an excuse for their dismissal from school.

Pursuant to O.C.G.A. §20-2-692, “Children who serve as Pages of the General Assembly during the school year, either at regular or

special sessions, shall be credited as present by the school in which enrolled in the same manner as an educational field trip, and such participation as a Page shall not be counted as an absence, either excused or unexcused.”

## Parents/Guardians

You are encouraged to stay at the State Capitol during the time your student will be serving as a Page. However, should the legislative day run shorter than expected your child should be able to communicate with you by phone in order to expedite the check out process.

You can watch the day's session from the House gallery on the fourth floor. Cameras are permitted in the gallery, but flash photography is prohibited. Cell phone use is also prohibited in the gallery. Kindles, Nooks, iPads, laptops or other electronic devices are permitted in the House gallery, but must remain silent.

If you are staying during a lunch break, there are two nearby cafeterias.

### Cafeterias :

#### ◇ Coverdell Legislative Office Building (also referred to C.L.O.B.)

– 6th floor: Across from the Capitol on Mitchell Street.

#### ◇ Sloppy Floyd Building (also referred to as Twin Towers)

– 1st floor: Across from the State Capitol at the corner

## Directions to the State Capitol – Atlanta, Georgia

**From the South:** Take I-75/85 North to Exit 245 (Capitol Avenue). At the bottom of the exit ramp continue straight after the stop sign. At the first traffic light, turn left onto Hank Aaron Drive and the State Capitol will be approximately one mile on your left.

**From the North:** Take I-75/85 South to Exit 248A (Martin Luther King Jr. Drive). Bear right onto Martin Luther King Jr. Drive and the State Capitol will be on your left.

**From the East:** Take I-20 West to Exit 58A (Capitol Avenue). Turn right onto Capitol Avenue and the Capitol will be approximately one mile down on the left.

**From the West:** Take I-20 East to Exit 56B (Windsor Street/Spring Street/Stadium). At the third light, turn left onto Central Avenue. Turn onto Mitchell Street, turn right, and the State Capitol will be two blocks down on the left.
