




FROM RESOLUTION TO ROAD SIGNS:

THE 7 STEPS FOR DEDICATING A G.D.O.T ROAD FACILITY



ANY MEMBER OF THE GENERAL ASSEMBLY MAY CHOOSE TO DEDICATE A ROAD FACILITY FOR A PERSON OR GROUP THEY FIND DESERVING OF SUCH HONOR. THE MEMBER WILL CHOOSE A LOCATION ON THE STATE ROAD SYSTEM: A BRIDGE, AN OVERPASS, AN INTERSECTION, OR PORTION OF HIGHWAY.

STEP 1

STEP 2

ONCE THE LOCATION IS CHOSEN, A MEMBER FILLS OUT THE REQUIRED FORM FROM G.D.O.T TO OBTAIN A CONFLICT LETTER. A CONFLICT LETTER INFORMS A MEMBER IF A LOCATION HAS PREVIOUSLY BEEN DEDICATED.

THE MEMBER GETS LEGISLATIVE COUNSEL TO DRAFT A RESOLUTION AND A NOTICE OF INTENT TO DEDICATE A ROAD FACILITY FOR PUBLICATION IN THE LEGAL ORGAN OF THE DISTRICT.


STEP 3

THE RESOLUTION MAY BE DROPPED INTO THE HOPPER IMMEDIATELY. THE AD MAY BE RUN SUBSEQUENTLY.

STEP 4

PROOF THE RESOLUTION BEFORE DROPPING IN THE HOPPER!

THE SPELLING OF ALL NAMES AND TITLES MUST BE ACCURATE BECAUSE WHAT IS IN THE RESOLUTION IS WHAT WILL GO ON THE ROAD SIGN!




RUN THE AD IN THE LEGAL ORGAN OF YOUR DISTRICT ONE TIME. SUBMIT A COPY OF THE PUBLISHED AD OR PUBLISHER'S AFFIDAVIT TO THE TRANSPORTATION COMMITTEE.

ALLOW FOR THE LEGISLATIVE PROCESS

RESOLUTIONS ARE CONSOLIDATED INTO ONE LARGE ROAD DEDICATION PACKAGE. A VERSION ORIGINATES IN EACH CHAMBER ALLOWING THE PROCESS TO EXTEND UNTIL THE LATE DAYS OF THE SESSION. EACH VERSION MUST BE SIGNED BY THE GOVERNOR, LIKE ANY OTHER BILL.



UPON SIGNATURE:

MEMBERS WILL CONTACT THE G.D.O.T DISTRICT OFFICE IN WHICH THE DEDICATION IS LOCATED TO COORDINATE SIGN MANUFACTURE AND INSTALLATION. THE DEPARTMENT INVOICES THE MEMBER UPON COMPLETION.
