HB 380 by SUBSTITUTE by Representative Riley of the 50<sup>th</sup>

FULTON COUNTY: A Bill to amend the act which created a system of pension and retirement pay for the Fulton County Board of Education so as to provide that it shall be the plan sponsor and funding agent of such plan, to provide for the administration of the plan through a committee of the board of education, to provide for a committee known as the pension board, and to provide for the membership and duties of the pension board.

HB 528 by Representative Yates of the 73<sup>rd</sup>

FAYETTE COUNTY: A Bill to authorize the City of Peachtree City to levy a hotel/motel tax.

HB 561 by Representative Nimmer of the 178<sup>th</sup>

WAYNE COUNTY: A Bill to reapportion the board of commissioners of the City of Jesup.

HB 575 by SUBSTITUTE by Representative Rice of the 95<sup>th</sup>

GWINNETT COUNTY: A Bill to amend an Act to incorporate the City of Peachtree Corners so as to change certain provisions relating to the city's ability to enter into agreements with other governmental parties.

HB 589 by Representative Jackson of the 128<sup>th</sup>

WASHINGTON COUNTY: A Bill to reapportion the Washington County Board of Education.

HB 590 by Representative Kelley of the 16<sup>th</sup>

POLK COUNTY: A Bill to reapportion the Polk County Board of Education.

HB 591 by Representative Glanton of the 75<sup>th</sup>

CLAYTON COUNTY: A Bill to create a code of ethics and ethics commission for the Clayton County School System.

HB 593 by Representative Jackson of the 128<sup>th</sup>

WASHINGTON COUNTY: A Bill to reapportion the Washington County Board of Commissioners.

HB 594 by Representative Martin of the 49<sup>th</sup>

FULTON COUNTY: A Bill to amend an Act pertaining to the Fulton County Personnel Board and the Fulton County Merit System of Personnel Administration so as to provide that all future employees other than public safety shall be unclassified.

HB 596 by Representative Pruett of the 149<sup>th</sup>

TELFAIR COUNTY: A Bill to reapportion the election districts of the Board of Education of Telfair County.

HB 598 by Representative Willard of the 51<sup>st</sup>

FULTON COUNTY: A Bill to provide that Fulton County employees first or again employed on and after July 1, 2013, to serve the Superior Court of Fulton County, the Magistrate Court of Fulton County, or the State Court of Fulton County shall be employees at will.

HB 603 by Representative Evans of the 42<sup>nd</sup>

COBB COUNTY: A Bill to provide compensation for the judges of the State Court of Cobb County.

ROCKDALE COUNTY: A Bill to repeal provisions in the charter of the City of Conyers relating to the election and terms of office of the mayor and councilmembers.

SB 223 by Senator Harbison of the 15<sup>th</sup>

SCHLEY COUNTY: A Bill to reapportion the Schley County Board of Commissioners.
