GWINNETT COUNTY: A Bill to create a new charter for the City of Sugar Hill, so as to change provisions relating to municipal property ownership.

HB 1117 by Representative Quick of the 117th

CLARKE COUNTY: A Bill to amend an Act creating the Downtown Athens Development Authority, to define and create the Downtown Athens Area.

HB 1118 by Representative Jackson of the 128th

WASHINGTON COUNTY: A Bill to provide for the filling of vacancies on the Washington County Hospital Authority.

HB 1119 by Representative Petrea of the 166th

CHATHAM COUNTY: A Bill to abolish the office of elected county surveyor of Chatham County.

HB 1120 by Representative Burns of the 159th

SCREVEN COUNTY: A Bill to authorize the governing authority of the Board of Commissioners of Screven County to levy a hotel/motel tax.

HB 1121 by Representative Pezold of the 133rd

HARRIS COUNTY: A Bill to provide a new charter for the City of Hamilton.

HB 1122 by Representative Rhodes of the 120th

OGLETHORPE COUNTY: A Bill to create a Board of Elections and Registration for Oglethorpe County, to provide for its powers and duties.

HB 1123 by Representative Blackmon of the 146th

HOUSTON COUNTY: A Bill to authorize the governing authority of the City of Warner Robins to levy a hotel/motel tax.

HB 1124 by Representative Pirkle of the 155th

IRWIN COUNTY: A Bill to reconstitute the Ocilla-Irwin County Industrial Development Authority, to provide for powers, authority, funds, purposes, and procedures connected therewith.

HB 1125 by Representative Morris of the 156th

APPLING COUNTY: A Bill to provide a new charter for the City of Surrency.

HB 1126 by Representative Morris of the 156th

APPLING COUNTY: A Bill to provide a new charter for the City of Graham.

HB 1127 by Representative Morris of the 156th

MONTGOMERY & TOOMBS COUNTIES: A Bill to create the City of Vidalia Convention and Visitor's Bureau Authority as a public body corporate and politic, a political subdivision of the state, and a public corporation.

HB 1128 by Representative Cheokas of the 138th

CHATTAHOOCHEE COUNTY: A Bill to reconstitute the Chattahoochee County Board of Education with staggered terms and nonpartisan election for members.

SB 419 by Representative Williams of the 19th

WAYNE COUNTY: A Bill to amend an Act establishing the State Court of Wayne County, so as to change the salary of the judge and solicitor.
