

# LOCAL LEGISLATION CALENDAR

## GEORGIA HOUSE OF REPRESENTATIVES

HB 638 by SUBSTITUTE by Representative Rutledge of the 109th  
CITY OF STOCKBRIDGE: This bill revises the corporate boundaries of the City of Stockbridge.

HB 832 by SUBSTITUTE by Rep. Hilton of the 95<sup>th</sup>  
CITY OF PEACHTREE CORNERS: This bill provides a new charter for the City of Peachtree Corners.

HB 839 by Rep. Glanton of the 75th  
CLAYTON COUNTY: This bill changes the compensation of the members of the Clayton County Water Authority to \$525 per month.

HB 845 by Rep. Gurtler of the 8th  
CITY OF YOUNG HARRIS: This bill provides a new charter for the City of Young Harris.

HB 846 by Rep. Collins of the 68th  
CITY OF VILLA RICA: This bill authorizes the City of Villa Rica to exercise all redevelopment and other powers found under Article IX, Section II, Paragraph VII(b) of the Georgia Constitution and Chapter 44 of Title 36 of the O.C.G.A.

HB 864 by Rep. Glanton of the 75<sup>th</sup>  
CITY OF JONESBORO: This bill changes the corporate limits of the City of Jonesboro.

### **PURSUANT TO ARTICLE VII, SECTION II, PARAGRAPH IV OF THE STATE CONSTITUTION, THE FOLLOWING LOCAL BILLS RELATING TO HOMESTEAD EXEMPTIONS REQUIRE A TWO-THIRDS ROLL-CALL VOTE FOR PASSAGE:**

HB 863 by Rep. Glanton of the 75<sup>th</sup>  
CITY OF JONESBORO: This bill grants each resident of the City of Jonesboro an exemption from city ad valorem taxes for municipal purposes. The exemption gradually decreases from \$50,000 in 2019 to \$10,000 in 2023 and thereafter.

HB 707 by SUBSTITUTE by Rep. Price of the 48<sup>th</sup>  
CITY OF ROSWELL: This bill provides a homestead exemption — which has the effect of a valuation freeze — from City of Roswell ad valorem taxes for municipal purposes.

HB 708 by SUBSTITUTE by Rep. Raffensperger of the 50<sup>th</sup>  
CITY OF JOHNS CREEK: This bill provides a homestead exemption — which has the effect of a valuation freeze — from City of Johns Creek ad valorem taxes for municipal purposes.

HB 710 by SUBSTITUTE by Rep. Jones of the 47<sup>th</sup>  
CITY OF MILTON: This bill provides a homestead exemption — which has the effect of a valuation freeze — from City of Milton ad valorem taxes for municipal purposes.

HB 711 by SUBSTITUTE by Rep. Jones of the 47<sup>th</sup>  
CITY OF MOUNTAIN PARK: This bill provides a homestead exemption — which has the effect of a valuation freeze — from City of Mountain Park ad valorem taxes for municipal purposes.

HB 712 by SUBSTITUTE by Rep. Martin of the 49<sup>th</sup>  
CITY OF ALPHARETTA: This bill provides a homestead exemption — which has the effect of a valuation freeze — from City of Alpharetta ad val orem taxes for municipal purposes.

SB 317 by SUBSTITUTE by Sen. Albers of the 56<sup>th</sup>  
FULTON COUNTY: This bill provides a homestead exemption — which has the effect of a valuation freeze — from Fulton County school district ad valorem taxes for educational purposes.
