- **SB 235** – **Senator Sonya Halpern of the 39<sup>th</sup>:** "HBCU Innovation and Economic Prosperity Planning Districts Act"; enact (**HEARING ONLY**)
- **SB 390** – **Senator Larry Walker, III of the 20<sup>th</sup>:** To amend Titles 20, 36, 43, and 50, related to libraries, education, governmental entities, professions and business; acceptance and use of funds

from the American Library Association prohibit under certain circumstances (**HEARING ONLY**)
