- HB 59 – Representative Wes Cantrell - relating to elections and primaries generally, so as to authorize the use of instant runoff voting for runoffs by overseas citizens and military personnel; to provide for special absentee ballots for such purpose.
- HB 64 – Representative Houston Gaines - relating to primaries and elections generally, so as to provide for the manner of handling the death of a candidate prior to a nonpartisan election; to provide that no candidate shall take or be sworn into any elected public office unless such candidate has received a majority of the votes cast for such office except as otherwise provided by law.
- HB 136 – Representative Eddie Lumsden - relating to primaries and elections generally, so as to provide for the appointment of acting election superintendents in the event of a vacancy or incapacitation in the office of judge of the probate court of counties without a board of elections; to provide for resumption of the duties of election superintendent upon the filling of such vacancy; to provide for the compensation of such acting election superintendents
